

# PROJECT UPDATE

## Construction Begins April 2019

The Minnesota Department of Transportation will be starting the I-35W North MnPASS project in April 2019. The three-year construction project will repair aging infrastructure and improve mobility on I-35W between Co. Rd. C in Roseville and Sunset Ave. in Lino Lakes. Construction is expected to be completed in fall 2021.



## Improvements Coming to I-35W

When the I-35W North MnPASS project is done, there will be:

- New pavement on freeways and ramps
- Reconstructed I-35W bridges over Co. Rd. C, Rosegate/railroad tracks and Co. Rd. I
- A new MnPASS lane in both directions between Lexington Ave. and Co. Rd. C
- Additional lanes between some interchanges
- New noise walls

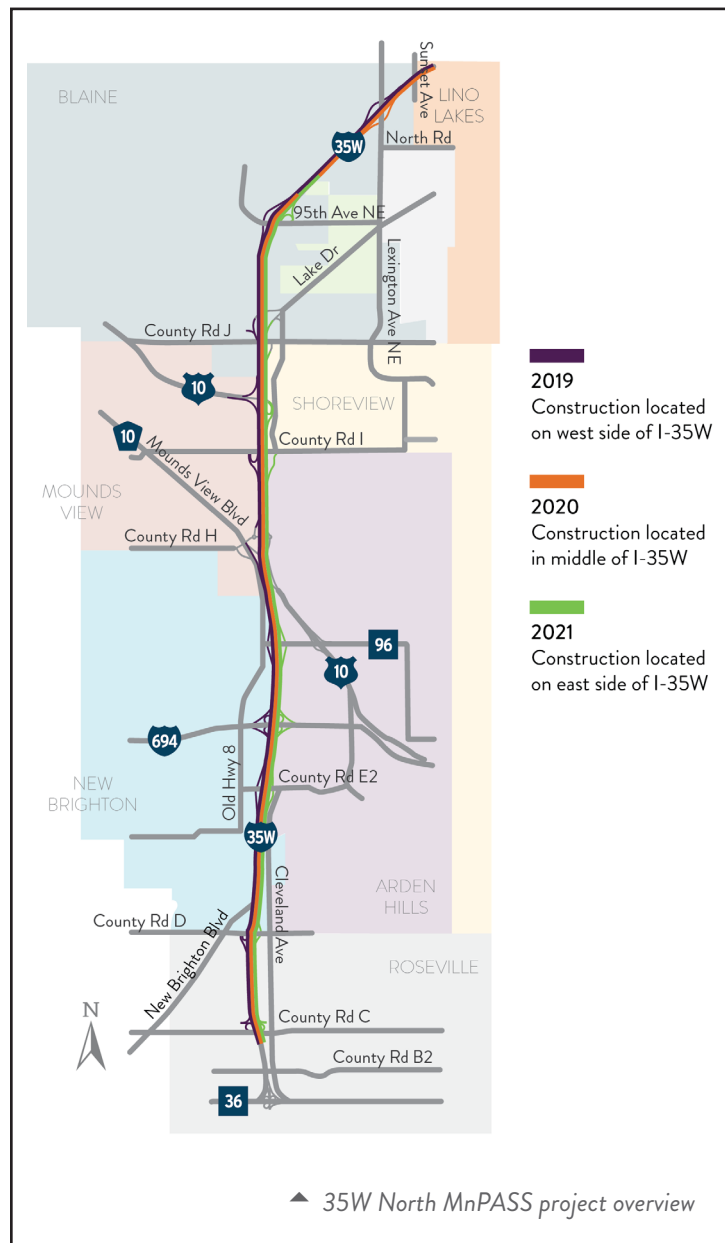
## Project Staging

- Construction activities will focus on the west (SB) side of I-35W in 2019
- Work will be in the middle of I-35W in 2020
- In 2021, work will be done on the east (NB) side of I-35W
- There will be long-term lane restrictions and ramp closures between April and November each year (see back for details on 2019 schedule and impacts)

# 2019 Construction Schedule and Impacts

## Long-Term Lane Restrictions

- Two lanes in each direction between Sunset Ave. and Hwy 10
- Three lanes in each direction between Hwy 10 and Mounds View Blvd. (Co. Rd. 10)
- Two lanes in each direction between Mounds View Blvd. (Co. Rd. 10) and Co. Rd. C

## Ramp Closures

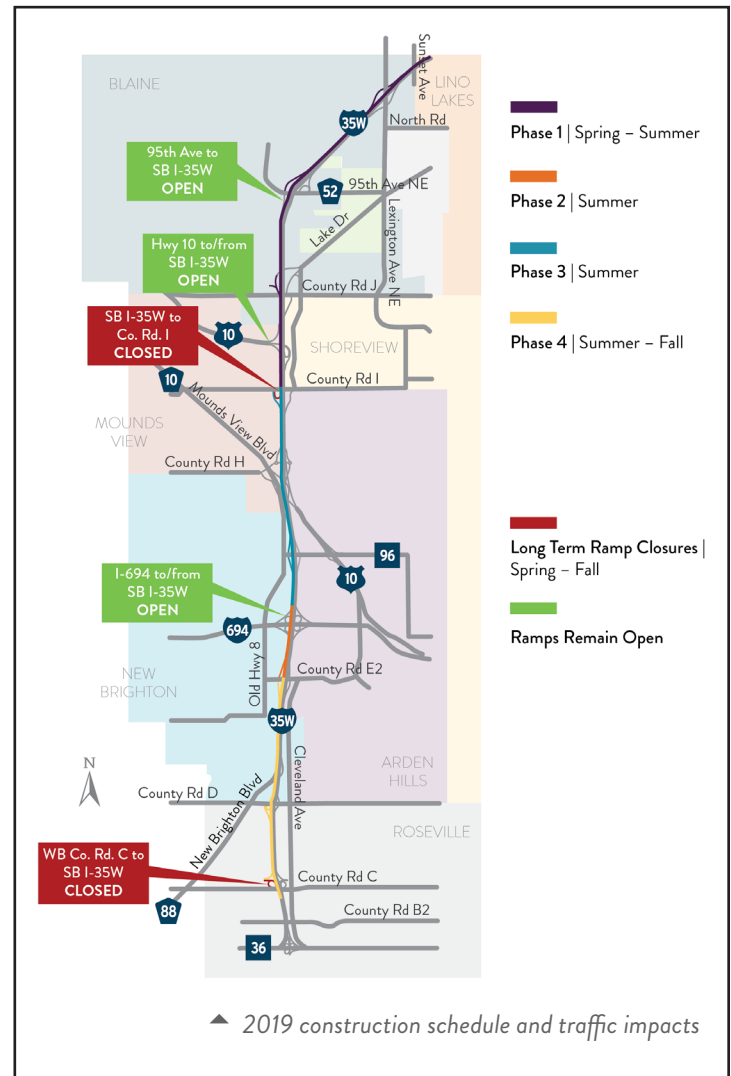
- Short-term ramp closures will occur on ramps within each phase
- Long-term ramp closures will occur at Co. Rd. I and Co. Rd. C
- Work will be phased so that no two ramps in a row are closed at the same time

## Ramps Remaining Open

- Ramps at I-694 and northern Hwy 10 interchange
- Ramp from 95th Ave. to southbound I-35W

## Noise Wall Construction

- Tree/brush removal at noise wall locations occurs in March 2019
- Walls on the west side of I-35W will be constructed spring-summer 2019
- Walls on the east side of I-35W will be constructed summer/fall 2019-spring 2020
- Properties near wall construction will receive additional notifications before work begins



## More Information

### Commuters/Truckers

- Be aware that lane widths on I-35W will be reduced to 11 feet
- Check 511mn.org before traveling for real-time updates on traffic speeds
- Temporary traffic control enhancements are being made on some local roads to help manage traffic, but anticipate impacts and delays on and near I-35W

### Residents

- Crews will generally work during daytime hours, Monday-Saturday, but some work may occur earlier or later or on Sundays depending on construction activities

### Business Owners

- Communicate with customers, employees, suppliers and vendors on how to access your location
- Contact MnDOT staff for detour recommendations and detour maps
